Utah's Post-Wildfire Team





Communities that are proactive and prepare and plan before a wildfire sparks are better able to respond in a post-wildfire situation.

The Post-Wildfire Team can assist in developing a Community Wildfire Protection Plan (CWPP) before an incident occurs, and can help a community obtain financial assistance for wildfire mitigation, response, and recovery.

When community leaders unite all of the affected parties, large-scale damage prevention and or recovery is often expedited. Utah's Post-Wildfire Team can also help communities identify and apply for disaster assistance for communities, individuals, and landowners impacted by wildfire.



Utah's Post-Wildfire Team

Utah's Post-Wildfire Team is comprised of state and federal agency representatives working together to support communities impacted by wildfire. When a large fire affects an entire community, Utah's Post-Wildfire Team can mobilize to meet with and advise community leaders and emergency managers and attend public meetings to educate the public about post-wildfire hazards and recovery strategies.

Additional assistance from community volunteers and local organizations like churches, non-profits, and businesses may also be available.

After a wildfire has been extinguished residual hazards exist. Wildfires dramatically change landscape and ground conditions, which can lead to increased risk of flash floods and debris flows. Utah's Post-Wildfire Team can assist residents and businesses downstream to better understand the hazards they face, give them steps they can take to reduce their risk, and resources available to assist them.

Utah's Post-Wildfire Team has expertise on which treatments will best help communities to recover, including treatments designed to mitigate flood after fire, to restore burned lands, and protect drinking water supplies.
